Ecotourism does not require heavy industrial investment. Its strength lies in small scale enterprises rooted in local participation. For rural households, this approach reduces financial risk while providing diversified income streams.

If a village operates five homestay rooms with an average occupancy of fifteen nights per month at ₹1200 per night, the monthly income would be ₹90,000. Over a year, this equals approximately ₹10,80,000. For multiple villages, the collective impact becomes significant.

Similarly, a mangrove safari unit conducting twenty trips per month with six visitors per trip at ₹1000 each can generate ₹1,20,000 per month before expenses. Such earnings can substantially improve household income levels.

These examples demonstrate that ecotourism is not merely a conceptual idea but a financially viable opportunity when organized systematically.

For ecotourism to succeed, community effort must be supported by appropriate policy frameworks.
